- How to surplus items safely (ie. There are sometimes hazards like lead paint on items)
 - Why: Things that are university property may not be sold or given away by departments, but instead scheduled to be removed by UW Surplus
 - How: Surplus request form, contacting UW Surplus, drop off at Surplus or have moving service complete
 - Items might need Decon (decontamination) form when being surplus or removed from their home area - temp control devices, ventilation devices, lab furniture, fixtures, cabinets, mixture and separation devices, instruments and equipment)
 - There is a list of prohibited items and conditionally accepted items to be aware of.

o EH&S cannot decontaminate items for you (common misconception)
